Subject: Confederate Command Report

Event Attendance – The ACWS has an Annual Raffle that is held at the Calico Event. To be eligible for a raffle ticket(s) you must be an ACWS member AND attend an ACWS event. A person earns one ticket per day per event for their attendance; an 'extra' ticket is earned if you 'volunteer' to do extra activities for the ACWS (i.e., putting up organizational tent, etc.). At the end of this column is a listing of those that have attended an ACWS event (Calico, St Cat, Costa Mesa, SMR, Vail Lake), how many tickets they have earned, and if they are an ACWS member. Only 'soldiers' on the Confederate side are noted on this listing. So, if you took the field as a Confederate, please check the listing for correct number of tickets earned. IF you have too few or even too many tickets, please let your Unit Commander/1st Sergeant know so they can put together a consolidated corrected morning report for your unit and others in your unit. The morning report will be sent to David Grimsrud, Division Adjutant, for inclusion in the final listing of attendees and tickets earned. For the raffle, member need not be present. Amended Morning Reports need to be submitted by February 1, 2013.

## Past Events -



Two new units attended **Vail Lake** event in December. On the left is 'Private Gut Eater Jones' of the 32nd Velociraptor Infantry (CS). We only see one problem; his arms are way too short for a three-band rifle. In addition to the usual battles, on Saturday night was a 'period' Christmas get-together with Santa Claus, carols, a band concert and sing along, a reading of "A Visit from St. Nicholas, tree trimming, and refreshments. This was more of a 'try-out' the site event to see how it would work, and plans are being made to have an event on Memorial Day weekend in May. Things I liked about the site are the tremendous openness of the battlefield, although members of the new units seemed to get in the way.

**Future Events** - A wide variety of activities are coming up in the local area for the next three or four months. Besides reenactments, there will be living histories, period holiday celebration, and live fire opportunities.

January 19-20—Live Fire sponsored by the IVLHA/ACWS, near Seeley, CA.

January 26-27—Yuma Quartermaster Depot. Mostly a living history event. Location - 201 N 4th St, Yuma, AZ.

February 1-3—Tall Ships sponsored by the Washington Artillery. Mostly living history, with potential recruiting. We also 'fire' on the tall ships as they leave the harbor for their 'four hour cruise.' At Ventura Harbor, CA.

February 9—Lincoln Memorial Shrine – a living history event celebrating Honest Abe's birthday. Location: 125 West Vine Street Redlands, CA.

February 16-18—Calico. Annual ACWS Event. In past year's one was required to be a member of the ACWS, but not this year. It is being opened up to all to participate. Event goes until Monday, which is a holiday for most people. ACWS would appreciate it if you stay over an extra day. Also, if you stay over, there's a free meal on Monday!! There will be a raffle for those members of the ACWS that participated in an ACWS event in 2012. An additional ticket is given for 'extra' duties like overnight guard mount and such. Winner need not be present. Confederate side is on the South this time, in the 'pits' (horseshoe pits). We hope to have a 'Civilian Town' to the south and east of the Confederate Camp, for those civilians that are camping out. If RVing, contact Park directly for reservations. Location: Calico Ghost Town, Yermo, CA.

March 16-17—St. Catherine's Military Academy - Annual event in Anaheim. Mostly living history and answering questions from students from St Cat's and surrounding school districts. Location: 215 N.

Harbor Blvd., Anaheim, CA.

March 16-17—Picacho Peak, Arizona Territory. Tom Atkins usually goes and commands a consolidated Confederate unit from South California. Here you can wear your ‘yahoo’ clothing. Most all Confeds wore their normal frontier Texan clothing; very few had full complete military uniforms. Location: Picacho Peak Park, 60 miles south of Phoenix and 40 miles north of Tucson. The park is ‘truly’ right off the freeway. Figure about 7 hours of driving, at least from downtown LA.

**150th Gettysburg Event** – The event seems to be getting together. From review of the event web site, many permits and permissions have been obtained. The BGA event will be held on June 27-30. A second event sponsored by the GAC is on the next weekend July 4-7. Discussion with most individuals/groups/commanders from South California indicates they will be attending the BGA event, although some may stay over a week and do the GAC event too.

In mid-December a press release was sent out by the BGA dealing with their event. Here is a summary of what the PR spelled out: The 150th Commemoration and Reenactment of the Battle of Gettysburg, put on by the Blue Gray Alliance June 27-30, 2013 in Gettysburg, promises to be a once in a lifetime event and people are coming together from far and wide to be a part of it. Reenactors come for the “period rush” historical accuracy brings and at \$10 per day (children 12 and under free), tour operators and spectators come to witness the recreation of one of the most historic moments in American History. Over the four days, June 27-30, 2013, elements of almost every reenacting organization in the country will reenact the major battles including McPherson’s Ridge, East Cemetery Hill, Culp’s Hill, A.P. Hill’s attack, Longstreet’s attack, Little Round Top, Fairfield and East Cavalry Field cavalry battles and Pickett’s Charge. Spectators will also be able to view weapons demonstrations, living history interpretations, fighting through the civilian-only “Town of Gettysburg”, food vendors, sutlers, historical lectures, period music, clothing demonstrations, period church services, and a Civil War Ball as well as other family-friendly activities. With an attendance of over 20,000 re-enactors (Author’s Note: I believe it was almost 27,000) at the 135th Gettysburg event, the 150th Commemoration and Reenactment of the Battle of Gettysburg is being planned on a grand scale. The site offers a sprawling, rugged landscape located near the southwestern section of the Gettysburg National Military Park including panoramic views of the Round Tops and the Eisenhower Farm from the hilltops. Some planned improvements include constructing a fence and stone wall for Pickett’s Charge, clearing brush areas, and improving roads for better traffic flow. Work days for this activity are being discussed and will be put together in coming weeks. Other recent site preparations include camps laid out, vendor and parking areas established, civilian-only “Town of Gettysburg” plotted out, and entrance areas improved. All event proceeds go to historical preservation through funding future events. “The Maps of Gettysburg” is being used to lay out the battle scenarios. Two major film crews have asked permission to film at the event and the Gettysburg Visitors and Convention Bureau has extended offers of partnership to make the event as beneficial as possible for the community as well. The Blue Gray Alliance has committed to providing quality events administered by reenactors in order to heighten the experience and offer a highly authentic presentation. ## A Brief History of the 10th Virginia Volunteer Infantry Regiment

The 10th Virginia Volunteer Infantry Regiment had its origins in volunteer militia companies organized in the late 1850's in Rockingham County, VA. Some of these units, then called the Valley Guard, were summoned to Harper's Ferry in response to the John Brown rebellion, where they served as guards during Brown's trial and execution. Before the outbreak of the War Between the States, seven companies that would become the nucleus of the 10th Virginia were organized as the Fourth Regiment Virginia Infantry, a volunteer militia regiment. When the Order of Secession was passed in Virginia on April 17, 1861, the various companies were ordered to Harper's Ferry, where they eventually were organized as the 10th Virginia Volunteers, drawn almost entirely from the Shenandoah Valley of Virginia. Eleven companies made up the 10th Virginia. Seven companies were drawn from Rockingham County, two from Shenandoah County, one from Page County and one from Madison County. A total of about 1,475 men in all served in the 10th during the time when the regiment was under arms. As part of the Army of Northern Virginia, the regiment saw action in almost every major engagement that was fought in Virginia, Maryland (except Sharpsburg) and Pennsylvania. From 1,475 men under arms, the 10th Virginia was decimated by battle injuries and disease. When the war ended with the surrender of the Army of Northern Virginia at Appomattox Court House on April 9, 1865, only about 45 men from the 10th were left. Of those 45, only 11 were still able to carry arms and fulfill their duties. Side Note: The 10th Virginia and 8th Louisiana were in the same Division (Gordon's) from mid-1864 to the end of the war. Both were in 'consolidated' Brigades, made up the remnants of regiments that had reduced manpower.

This is the flag that the 10th Virginia Infantry carried at 1st Manassas. First Confederate National Flag pattern, with 13 hand-painted gold stars on obverse side, Virginia State Seal painted on reverse of union. Partially shot

away by cannonball, fragments of which were saved. Gold fringe on 3 sides, 4 pair of ties at leading edge. Hand sewn throughout. Marked Horstmanns Phil (manufacturer and City manufactured [Philadelphia]). This marking is below state seal. Physical Description: Material: Silk; H: 115.5 (cm), L: 211.0 (cm).

## Civil War History

No matter what time in history, civilians are part of the casualties resulting from war. They suffer the loss of loved ones who are fighting, of friends that are trying to defend their homes against invading soldiers, of property, and frequently self-dignity due to atrocities committed. But civilians also are important to provide care and comfort for the wounded. In the Civil War, boundless diaries and journals document the role of civilians, especially women, as nurses in hospitals. One of these was Louisa May Alcott, author of Little Women and Little Men. Before she wrote these famous novels, Alcott's first work was Hospital Sketches, an account of her work as a nurse, which she documented in letters to her family. After serving for only a month, Alcott contracted typhoid and had to go home.

In Hospital Sketches, Alcott described her response to the wounded from the Battle of Fredericksburg, fought in November of 1862. She wrote:

"The sight of several stretchers, each with its legless, armless, or desperately wounded occupant, entering my ward, admonished me that I was there to work, not to wonder or weep; so I corked up my feelings, and returned to the path of duty, which was rather 'a hard road to travel' just then. The house had been a hotel before hospitals were needed, and many of the doors still bore their old names; some not so inappropriate as might be imagined, for my ward was in truth a *ball-room*, if gun-shot wounds could christen it. Forty beds were prepared, many already tenanted by tired men who fell down anywhere, and drowsed till the smell of food roused them. Round the great stove was gathered the dreariest group I ever saw — ragged, gaunt and pale, mud to the knees, with bloody bandages untouched since put on days before; many bundled up in blankets, coats being lost or useless; and all wearing that disheartened look which proclaimed defeat, more plainly than any telegram of the Burnside blunder. I pitied them so much, I dared not speak to them, though, remembering all they had been through since the rout at Fredericksburg, I yearned to serve the dreariest of them all."
