CONFEDERATE COMMAND:

*Hdqtrs, Infantry Brigade, Near Blythe,
Ca.
April 28, 1864.*

*Major Steve Hutton,
Chief of Staff, Stidger's Division*

*Major: I have the honor herewith
to submit to you a report of the
operations of my command from April
18 to April 19, 1864, embracing the
several engagements near Blythe,
California.*

*Reports from the Cavalry
Brigade indicated that Union forces
were concentrating in the vicinity of
Blythe. In response to this reported
buildup, the Infantry Brigade was
ordered to move to the vicinity of
Blythe and be prepared to counter any
move the Union forces might make.*

*With Union troops reportedly
still in the vicinity of Prado Park and
possibly preparing to move to the
vicinity of Costa Mesa it was necessary
to leave several companies of the
Brigade there to counter that threat.
The remainder of the Brigade
consisting of the 8th Alabama Co. I and
part of Co. E 8th Louisiana were ordered
to proceed to the vicinity of Blythe.
These elements arrived on Friday and
set up camp. Union troops were
observed moving into the area and
setting up camp also.*

*Saturday morning dawned
bright and we were able to observe that
the number of Union forces appeared
to be equal with our own. The Infantry
started out the day with drill as they
had a fresh fish and they wanted to be
ready to meet the Union forces.*

*About 1:30pm the Infantry was
ordered to advance forward of the
guns and form a skirmish line. As they
advanced a Union battle line came
out to meet them. At one point in the
battle Union brought up a mountain
howitzer on the right side of their line
which had a devastating effect on our
battle line. One of our field guns took
out the mountain howitzer and the
infantry continued to press the Union
line until they were compelled to
capitulate.*

*About 3:30pm the Infantry was
ordered to return to the field.
Initially, the Infantry force was split
half on the right side of the field and
half on the left side of the field. At one
point 1st Sergeant Fernand of the 8th
Alabama was shot & killed by a Union
soldier. 1st Sergeant Fernand's wife
Kathy came from the rear where she
had been tending the wounded,
yelling "you killed my husband". She
wrestled Pvt. Dudley's musket from him
and shot the offending Yankee dead.
The battle continued to rage for some
time until it was necessary to retire
from the field in the face of superior
forces.*

2ND. Kentucky Head Quarters
Bell's Station
Date May 12

To: Col Shawn Stidger
C.S.A. Division

Sir,

Upon my arrival to Costa Mesa Town I stopped the advance of our Cavalry at Fairveiw Park which is a short distance from my farm. I had the area secured and we watched the Federals set up camps closer to the Bluffs. The ground here is good for a fight which I knew would happen soon. On May 9Th as ordered we checked the Federal Line on the Left Flank met some resistance but pushed the Federal line back as our own Infantry advanced I saw the opportunity to pull off line and run my Brigade behind our own line to mask my plan. We came out on our far right flank to hit the Federal weak point there. With the efforts of both Infantry and Cavalry moving in coordinated advance maneuvers, I was able to cut off the Federals escape as well as capturing the Federal Battery. Casualties were light for my Brigade, and we made ready for any other Federal

advance. Just before sunset the Federal advance did come and my Brigade found themselves cut off from our Infantry lines we were being cut down like chafes of wheat. I ordered a retreat and we left the Field with heavy casualties to the Brigade. On the morning of May 10 I found the Brigade low in numbers but high in honor for those who remained to finish the fight. At first we were pushed further back but by the afternoon we captured a Howitzer to present to you and our Chief of Artillery. I and a few other troopers ran the gun until we ran out of rounds. At that point I asked permission to leave the piece and join my Brigade. Captain Inman led the Cavalry Brigade until my return. With our Infantry pushing hard on the Federal right flank and Center it gave me the opportunity to crush the Federal Battery standing unprotected and then giving me room to block the Federal retreat. Fairveiw Park Station is in Confederate hands.

17 May, 1863

To: ACMB Confederate Division

Gentlemen,

I have to apologize for not writing this in my own hand. Time has escaped me. I want to thank you for a successful Winter-Spring campaign. We have held the silver at Calico and forced the federal army back the Arizona border. We had them just about if South California but they rallied. We met the Federal counterattack in Costa Mesa to resounding results. I asked for a decisive victory and that is exactly what was delivered, capturing 3 guns in two days. My compliments to you all. I have no idea if we can catch up to the Federal army because watching their color bearer run, I did not know if has stopped yet, but he moved fairly quickly. I also would like to thank Kanawah's Cavalry Brigade for their assistance, it was invaluable. We also got ourselves back into the win column in Base Ball. We won, and I think the score was 8 to 3.

The Cavalry is out and scouting for us and we will be patient until we find where the Federal army is going to amass again. The latest word from our spies we have is they will meet again in October for a late fall campaign starting in Menifee. Instead of forcing them to Arizona, I would like to drive the Federals through Nevada this time. We will be prepared for this attack. I am currently searching for farm for us to drill on. I have a potential place near Cherry Valley and will have word to you folks soon. I am looking about mid-August for this drill. Please contact your brigade commander if you are interested. I am planning having a very good trip to an old friend's we can have a great area to drill on.

Another item I would like to address with the best Confederate Troops in South California. I would like the company commanders to send historical facts about your companies to the Asst. Adj. Gen. Gene Somers. You can send him a letter through wire to this address:

grumpyolslob@aol.com. We would like to start incorporating these into the battles and start having the respective brigades portray the company we are doing the scenario for. For example, the 8th Alabama charged a fortified position and captured 2 cannon. The infantry would take the field as the 8th Alabama, with their colors. The Infantry brigade would portray the 8th for that battle. I would like to do this for each company we have in our ranks.

I would like thank you all, for attending the events we have had. They have been on short notice

and they have been enjoyable. The folks in Blythe have treated us very hospitably and I thank them for all of the support. I can see this Confederate Division is going to be the strength for our cause and keep the drums beating until the Federal Government relents on their oppression.

FINAL VERSION (as adopted 1-31-04)

Definitions:

Sponsored events – This event is completely sponsored by the ACWS. We provide insurance, artillery reimbursements, infantry powder issues, approved impressions, provide for command structure, make maximum effort to turn out membership, publicize event in our newsletter, and cover any additional expenses required. We contract and control any proceeds. All conditions above will be specified in written contract.

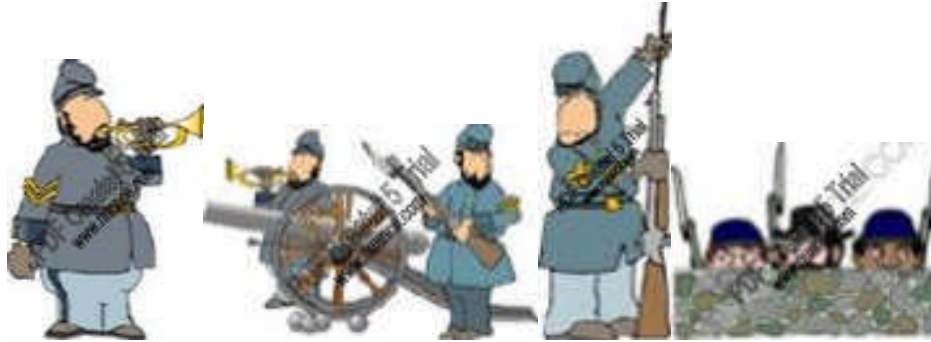
Co-sponsored events– This event is co-sponsored by the ACWS in association with an other recognized entity. We will provide ACWS member insurance and may provide event insurance at additional cost. (if ACWS event insurance is used, ALL ACWS rules and regulations as published in ACWS gold book SHALL apply). Event will provide artillery reimbursements, infantry powder reimbursements and additional expenses (subject to negotiations) at normal ACWS rates. ACWS will provide approved impressions, provide and/or share command structure, make maximum effort to turn out membership, publicize event in our newsletter, and cover any additional expenses negotiated and required. All conditions above will be specified in written contract.

Supported events – ACWS provides auxiliary support for this event. **We provide liability insurance for our registered members only**, we can not provide event insurance. ACWS provides no artillery reimbursements, no infantry powder issue. ACWS recommends inclusion of our impressions (i.e. Grant/Lee) and shares command positions. ACWS advertises event in the ACWS newsletter. We may receive proceeds from this event by agreement.

Conditions for support:

- 1) All members of ACWS will be accepted without exception.
- 2) Artillery gun slots will be guaranteed at least 2 ea. Confederate and 2 ea. Union for ACWS full sized guns (batteries to be determined by ACWS).
- 3) Artillery powder reimbursement will be paid to ACWS guns at the same rate as those applied to *any and all other* full sized cannon participating in the event.
- 4) ACWS units will be held within one cohesive military unit (brigade/battalion etc.) and be commanded by ACWS command structure.
- 5) ACWS command staff (U.S. and C.S.) will be included in scenario planning.
- 6) Participating ACWS members will adhere to ACWS safety rules and regulations. These rules and regulations will supersede any other event rules for our members.
- 7) ACWS will be allowed to establish and staff an informational/promotional booth at this event.

Recommended events–ACWS will list this event in our calendar. **NO ACWS INSURANCE WILL APPLY.**

5th US Battery B featured on History Channel

JENNY LIND

The following cake was named for Jenny Lind, the greatest soprano of the mid-eighteen hundreds. The "Swedish Nightingale," as she was fondly called, made only one U.S. tour, 1850-1852. For anyone who had the privilege of seeing her, it was a rare and thrilling occasion. In 1851, Benjamin Grierson, his sister Mary, his brother John, and John's wife Elizabeth all shared this experience. The following is taken from a letter written by Mary Grierson to her future sister-in-law Alice Kirk, describing the events that surrounded her journey from Jacksonville to St. Louis to hear Jenny Lind:

"Oh! I must not forget the joy of my life. I have heard—have seen—Jenny—living—breathing—singing, Jenny Lind. I must say only what all say that she is above all description. She must be heard. Could I have known what I would have lost by not hearing her, it would have been a life-long sorrow, but I have heard her. I could talk of her for hours, but I cannot write. When she came to St. Louis, Ben went down to hear her. I thought it right. But the high price of the tickets compelled me to decide that I ought not to think of such an indulgence for myself. John was there on business—went to the first concert—came home with such descriptions of her music and such an urgent request for me to come that Elizabeth, Mr. Howard and I set off. I shall always be glad that I have heard her. Indeed I would have considered myself paid—for expense and trouble—in listening to one solo on the violoncello played by a young man—one of the orchestra. Oh! I wish you could have heard it. Our seats cost us \$6.50 each—besides the expense of going and coming and our expenses there. The poor I know ought not to expect to indulge themselves as the rich can, but we cannot estimate Jenny Lind's singing in dollars and cents. They are nothing. She gave five concerts in St. Louis. Ben heard them all."

THE JENNY LIND CAKE

2 eggs	3-½ cups flour
2 cups of sugar	3 teaspoonfuls baking powder
½ cup of butter	Flavor to taste, rind of the
1 cup of sweet cream or milk	lemon, if thought best, salt

Cream for the inside

2 apples, grated
 1 cup of white sugar
 1 egg. Cook until it boils up, then add the juice of one lemon.
 To be baked like Jelly Cake and spread with the cream.

2 cups sugar	3 teaspoons baking powder
½ cup butter, margarine, or lard	1 teaspoon salt
2 eggs, large	1 teaspoon vanilla or 2 teaspoons
1 cup sweet cream or milk	lemon or orange peel, grated
3-½ cups flour	

Cream the sugar with shortening until light. Add eggs and beat well. Stir in milk and flavoring. Sift flour, salt, and baking powder together and add to the creamed mixture. Blend until batter is smooth. Turn batter into two 9-inch layer pans that have been greased and floured. Bake at 350° for about 35 minutes or until cakes test done.

Cream Filling

2 apples, grated or 1-½ cups applesauce
 1 egg (plus 1 tablespoon cornstarch if you do use applesauce and it is thin)
 1 cup white sugar
 2 to 3 tablespoons lemon juice or 1 to 2 tablespoons lemonade concentrate

Bring apples (or applesauce), beaten egg, and sugar to a boil. Remove from heat and add lemon juice or lemonade concentrate. When cakes are cool, split the layers. Place first layer of cake on the plate and alternate layers of cake and filling until both are used up.



egg beater
